Field Trial Conditions of Entry

1. Dogs entered at Kennel Club Licensed Field Trials must be registered at the Kennel Club in accordance with the Kennel Club Regulations for Classification and Registration The running order of the stake will be in the order of the draw.
2. More than one entry may be applied for; but no owner can be allocated a second entry until all entries have received an offer of a run. Post-dated cheques will not be accepted.
3. All entries must be via post or FTMS.info Postal entries must supply a SAE for each Trial entered, to receive a copy of the draw. Copy of the draw will be emailed to the registered email address on FTMS, it will also be available on FTMS and may be advertised on The Dukeries (Notts) Gundog Club web site.

4. All dogs resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry to the Show/Event can be made. All overseas entries without Authority to Compete will be returned to the exhibitor/competitor.
5. Entries must be in the hands of the Breed Secretary by the date shown on the schedule. Anyone unable to run must notify the Breed Secretary by telephone or text message. Email withdrawals will not be accepted.
6. KC Regulation J6.f applies to those being successful in the draw but not taking up the place. Substitution for similarly qualified dogs will be allowed. Reserves will be substituted for absentees at advertised time for start of the trial. You cannot substitute the handler after the draw date.
Competitors should report to the Chief Steward 15 minutes before the time for the start of the trial.
7. If entries exceed the number of permitted runners, the right to compete in a Trial shall be decided by ballot.
8. There will be a refund of entry fees, less expenses incurred by the Club, if the trial is cancelled. Administration fees are non-refundable under any circumstances.
9. The Field Trial will be held under Kennel Club Rules and Field Trial Regulations and thereafter at the discretion of the Judges. The Field Trial Committee for the day will be formed from those of the Field Trial Committee present, plus the Judges' ex-officio. Should circumstances so dictate the Society, in consultation with the judges may alter arrangements, as necessary. Such changes and the circumstances surrounding them will be reported to the Kennel Club.
10. The Dukeries (Notts) Gundog Club recommends that all dogs running should be protected against parvo virus and other contagious diseases. No bitch in season nor any dog suffering from a contagious disease will be permitted to run. and must be removed forthwith.
11. The Trial will be deemed to have commenced when announced by the Chief Steward; when all competing dogs and handlers must be present.
12. Only competing dogs or those fulfilling some official activity will be allowed on to the trial ground. All persons are to check with the Chief Steward before exercising their dogs.
13. Unless otherwise stated trophies are kept at the joint responsibility of the winners and the Club for one year. The winner will be responsible for engraving the trophy and for its return to the Breed Secretary before the next succeeding Field Trial. (Clean and in good order!)
14. The Club reserves the right to refuse entries. Competitors and spectators must always obey the red flag bearer and are required to be always of good behaviour facilitating the smooth running of the trial and consideration of the host's property and interests.
15. Persons attending the trial do so at their own risk.
16. Members gaining a run in Novice Stake 1 will be allocated PREF 2 of the draw of other Novice Stakes. The same system will apply to stakes of other categories. Swapping runs is not allowed.
17. No modification may be made to the schedule after publication except by permission of the Kennel Club, followed by advertisement in appropriate journals if time permits before the closing entries.
18. Judges at a Trial are prohibited from entering a dog which is recorded in their ownership or part ownership.
19. Videography and Photography will only be permitted with the express permission of the Chief Steward.
20. **Welfare of Dogs** An exhibitor (or competitor) whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met and should not knowingly put their dogs' health and welfare at risk by any action, default, omission or otherwise. A breach of this Regulation may be referred to the Board for disciplinary action under Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any field trial licensed by the Kennel Club. This shall apply at the venue or within the precincts of the trial.
21. **DOGS IN CARS ON HOT DAYS** Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take care of your dog(s). If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused
